AN ACT to amend the *Commonwealth and State Roads Agreement Act, 1926*, and to approve and ratify an Agreement made between the Commonwealth and the State with respect to the Construction, Reconstruction, Maintenance, and Repair of Roads. [1 April, 1937.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited as the *Commonwealth and State Roads Agreement Act, 1937*. Short title.

**2** The Agreement made the twenty-fourth day of June, one thousand nine hundred and thirty-six, between the Commonwealth and the State, a copy of which is set forth in the schedule, and which extends the operation of the Agreement authorised by the Principal Act (as varied by the Agreement approved by the *Commonwealth and State Roads Agreement Act, 1931*), is hereby approved and ratified.

**THE SCHEDULE.**

---

AGREEMENT made the twenty-fourth day of June One thousand nine hundred and thirtysix BETWEEN THE COMMONWEALTH OF AUSTRALIA (in this Agreement called "the Commonwealth") and the STATE OF TASMANIA (in this Agreement called "the State") :

WHEREAS by an Agreement in the form contained in the Schedule to the Federal Aid Roads Act 1926 of the Commonwealth and made on the twentythird day of August One thousand nine hundred and twentysix between the Commonwealth and the State (which Agreement was approved adopted authorized and ratified by the Commonwealth and State Roads Agreement Act 1926 of the State and is hereinafter called "the Principal Agreement") it was agreed (*inter alia*) that the Commonwealth would subject to and for the purposes of the Agreement provide the sum therein mentioned during the period of ten years commencing on the first day of July One thousand nine hundred and twentysix:

AND WHEREAS by an Agreement in the form contained in the Schedule to the Federal Aid Roads Act 1931 of the Commonwealth and made on the sixteenth day of July One thousand nine hundred and thirtyone between the Commonwealth and the State (which Agreement was approved adopted authorized and ratified by the Commonwealth and State Roads Agreement Act 1930 of the State and is hereinafter called the "Amending Agreement") it was agreed that the Principal Agreement should be varied as therein provided:

AND WHEREAS by the Principal Agreement as varied by the Amending Agreement it is provided (*inter alia*)—

- (a) that the Commonwealth will subject to and for the purposes of the Principal Agreement as so varied provide during each year of the period of five years commencing on the first day of July One thousand nine hundred and thirtyone and during the period of six months com-

mencing on the first day of July One thousand nine hundred and thirtysix a sum calculated as therein provided; A.D. 1937

- (b) that the Commonwealth shall in each year during the said period of five years and also during the said period of six months commencing on the first day of July One thousand nine hundred and thirtysix withdraw from moneys in the Trust Account therein mentioned and pay into the Sinking Fund therein mentioned an amount calculated as therein provided; and
- (c) that the State shall on the date therein mentioned in each year after the expiration of the said periods of five years and six months pay into the said Sinking Fund an amount calculated as therein provided until the conditions therein mentioned are fulfilled.

AND WHEREAS the Commonwealth and the State have agreed to vary the Principal Agreement as varied by the Amending Agreement in the manner hereinafter appearing:—

Now IT IS HEREBY AGREED as follows:—

1. This Agreement shall have no force or effect and shall not be binding on either party unless and until it is approved adopted authorized or ratified by the Parliaments of the Commonwealth and of the State.
2. The Principal Agreement as varied by the Amending Agreement shall be read and construed as if wherever the words "six months" appear therein the words "twelve months" were inserted in lieu thereof.
3. Subject to the variations made by this Agreement, the Principal Agreement as varied by the Amending Agreement shall be of full force and effect.

IN WITNESS WHEREOF the Prime Minister of the Commonwealth and the Premier of the State have hereunto set their hands the day and year first above written.
