**AN ACT to make special provision with respect to the sitting Members of the Legislative Council representing the Electoral Divisions of Meander and Tamar and to provide for related matters.**

**[Royal Assent 14 October 1982]**

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—This Act may be cited as the *Constitution (Meander and Tamar Legislative Council Electoral Divisions) Act 1982*. Short title.

Certain Members deemed to have been elected to represent certain Electoral Divisions.

**2**—(1) The Member of the Legislative Council representing the Legislative Council Electoral Division of Meander immediately before the day on which the *Constitution Amendment Act* 1980 commenced—

(a) shall be deemed to have been elected to represent the Legislative Council Electoral Division of Tamar on and from that day and shall retire as Member of the Legislative Council Electoral Division of Tamar at the periodical election to be held on the fourth Saturday in the month of May 1983 or on such other day (being a Saturday) in the month of May in that year as the Governor may, by proclamation under section 19 (4) of the *Constitution Act* 1934, appoint for the purpose in respect of the periodical elections to be held in that year; and

(b) shall be paid, and be deemed to have been entitled to receive on and from the day on which the *Constitution Amendment Act* 1980 commenced, the electoral allowance payable to the Member of the Legislative Council Electoral Division of Tamar.

(2) The Member of the Legislative Council representing the Legislative Council Electoral Division of Tamar immediately before the day on which the *Constitution Amendment Act* 1980 commenced—

(a) shall be deemed to have been elected to represent the Legislative Council Electoral Division of Meander on and from that day and shall retire as Member of the Legislative Council Electoral Division of Meander at the periodical election to be held on the fourth Saturday in the month of May 1985 or on such other day (being a Saturday) in the month of May in that year as the Governor may, by proclamation under section 19 (4) of the *Constitution Act* 1934, appoint for the purpose in respect of the periodical elections to be held in that year; and

- (b) shall be paid, and be deemed to have been entitled to receive on and from the day on which the *Constitution Amendment Act* 1980 commenced, the electoral allowance payable to the Member of the Legislative Council Electoral Division of Meander.
