ROADS AND JETTIES.

No. 41 of 1972.

AN ACT to amend the Roads and Jetties Act 1935.

[7 December 1972.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1—(1) This Act may be cited as the Roads and Jetties Act 1972. Short title and citation.
- (2) The Roads and Jetties Act 1935, as subsequently amended, is in this Act referred to as the Principal Act.
- **2** Section five of the Principal Act is amended by inserting in Application subsection (1) after paragraph (d) the following paragraph:—

 of Fund.
 - "(da) all costs and expenses (including the costs of supervision) incurred by the Minister while the Commonwealth Aid Roads Act 1969 is in force in or in connection with the maintenance of country roads within the Hobart Statistical Division and Urban Launceston, being the urban areas as defined and referred to in section two of that Act:".

CRESSY-LONGFORD IRRIGATION WATER.

No. 42 of 1972.

AN ACT to make better provision for the supply of water in the Cressy-Longford Irrigation Water District. [7 December 1972.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as the Cressy-Longford Irrigation Water short title. Act 1972.

Construction and interpretation.

- **2**—(1) This Act shall be construed as if it were part of the Water Act 1957.
- (2) In this Act, unless the contrary intention appears, "district" means the Cressy-Longford Irrigation Water District, appointed and defined by a proclamation dated the twenty-sixth day of May 1970.

Agreements.

- **3**—(1) The Commission may agree with the owner or occupier of any land in the district that it will supply the land with water from its waterworks that serve the district and that he will pay the Commission therefor as they both agree.
- (2) The Commission may supply water in accordance with such agreements and shall receive payments thereunder as revenue of its undertaking in and for the district.

COMPANIES (DEATH DUTIES).

No. 43 of 1972.

AN ACT to amend the Companies (Death Duties) Act 1969. [7 December 1972.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation

- **1**—(1) This Act may be cited as the Companies (Death Duties) Act 1972.
- (2) The Companies (Death Duties) Act 1969, as subsequently amended, is in this Act referred to as the Principal Act.
- 2 After section eight of the Principal Act the following section is inserted:—

Nonapplication of Act in certain cases.

"8A This Act does not apply to or in relation to prescribed securities held at the time of his death by a person who dies on or after the first day of January 1973.".
