

**CONSOLIDATED REVENUE FUND
SUPPLEMENTARY APPROPRIATION 1971-1972.**

No. 54 of 1972.

AN ACT to appropriate a further sum from the Consolidated Revenue for the service of the year ended on the thirtieth day of June 1972.

[19 December 1972.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as the *Consolidated Revenue Fund Supplementary Appropriation Act 1971-1972.* Short title.

2 The sum of \$5,516,087.10 that has been issued from the Consolidated Revenue for the service of the year ended on the thirtieth day of June 1972, shall be deemed to have been appropriated, as from the first day of July 1971, for the purposes and services expressed in the schedule. Appropriation of \$5,516,087.10.
