AN ACT to amend the *Dentists Act* 1919.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and the House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited as the *Dentists Act* 1937.

Short title.

2 The Principal Act is hereby amended—

- I. By inserting at the end of section five thereof the words “ of whom one shall be appointed by the Governor, and shall hold office during the Governor’s pleasure ”:

II. As to section seven thereof—

- (a) By deleting “the” and substituting “five” (at the beginning of subsection (1)) :
- (b) By inserting “elected” before “member” (in the first line of subsection (4)) :
- (c) By deleting “Two” to “re-election”(at the beginning of subsection (5)) and substituting “One or two, as the case may require, of the elected members shall retire each year” ; and deleting “the two” and substituting “those” (in that subsection) :

Section 14.

III. By inserting in section fourteen thereof—

- (a) “Is a British subject and” (after “who” in the first line) : and
- (b) “Upon any qualification obtained by him upon examination in that Kingdom” (at the end of paragraph 1.).

Transitory provisions.

3—(1) The amendment made by paragraph III. of section two shall be deemed to have had effect as from the thirty-first day of January, one thousand nine hundred and thirty-six.

(2) The amendments made by paragraphs I. and II. of section two shall take effect as from the first day of January, one thousand nine hundred and thirty-eight, and the following provisions shall apply in respect thereof—

- i. The Board shall provide by regulation for the retirement of one of the elected members at the thirty-first day of December now next or alternatively for the filling of one only of the periodical vacancies occurring as from that date : and
- ii. Such transitory provisions as may be necessary shall be prescribed for the rotational retirement of members in accordance with section seven of the Principal Act.

Dentists.

4 This Act shall expire on the date of the gazettal of a proclamation made under section eight of the *Statute Law Revision Act* 1934, effecting in the Principal Act, as from the date of such gazettal, the amendments made by this Act with such alterations, if any, as may be required to adapt the same for incorporation in the reprint of the Principal Act, but such expiry shall not affect the operation of section three.
