BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1 This Act may be cited as the Dairy Produce Act 1939. Short title.
- 2 The Principal Act is hereby amended—
 - I. By adding at the end of the title thereto the words "and to provide for the regulation of the manufacture and sale of margarine and other substitutes for butter":

- II. By inserting after the word "used" in the definition of "margarine" in subsection (1) of section three the words ", or capable of being used,": and
- III. By inserting after paragraph XI. of section thirtyfour the following new paragraph XI.A:—

"XI.A The regulation of the manufacture of margarine and butter substitutes (as defined by the regulations); the limitation of the quantity of margarine and butter substitutes which may be manufactured; the licensing of manufacturers of margarine and butter substitutes; and the cancellation of licences; but no regulation shall be made under this provision until the Governor is satisfied that each of the other States of the Commonwealth has enacted provisions to the like effect as the provisions of this paragraph."
