AN ACT to amend the Maintenance Act 1921. 128 September, 1951.1

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

1—(1) This Act may be cited as the Maintenance Act 1951. Short title (2) The Maintenance Act 1921*, as subsequently amended,

is in this Act referred to as the Principal Act.

EDUCATION.

No. 36 of 1951.

AN ACT to amend the Education Act 1932. [28 September, 1951.]

RE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

- 1—(1) This Act may be cited as the Education Act 1951. Short title,
- (2) The Education Act 1932*, as subsequently amended, commence-is in this Act referred to as the Principal Act.
- (3) This Act shall be deemed to have commenced on the first day of July, 1951.

What a bursary comprises.

- 2 Section twenty-five of the Principal Act is amended—
 - (a) by omitting paragraph I. of subsection (1) and substituting therefor the following paragraph:—
 - "I. To an allowance, towards the cost of purchasing the necessary text books, of seven pounds ten shillings per annum in the case of a junior bursary and ten pounds per annum in the case of a senior bursary:";
 - (b) by inserting in sub-paragraph (a) of paragraphII. of that subsection, after the word "State", the word "secondary";
 - (c) by inserting in sub-paragraph (b) of paragraph II. of that subsection after the word "school" the words "not being a State secondary school,", and by omitting from that sub-paragraph the words "ten" and "fifteen" and substituting therefor, respectively, the words "fifteen" and "twenty";
 - (d) by omitting from subsection (1A) the word "twenty" and substituting therefor the word "twenty-five";
 - (e) by omitting from subsection (2) the words "of twenty-five pounds per annum" and substituting therefor the words "at the appropriate rate prescribed in subsection (2A)"; and
 - (f) by inserting after subsection (2) the following subsection:—
 - "(2A) A boarding allowance under subsection (2) shall—
 - I. In the case of a junior bursary, be at the rate of twenty-five pounds per annum for the first two years of the duration of the bursary and thereafter at the rate of thirty pounds per annum: and
 - II. In the case of a senior bursary, be at the rate of thirty-five pounds per annum while the holder of the bursary is under the age of sixteen years, and thereafter at the rate of fifty pounds per annum.".

Regulations.

- 3 Section forty-seven of the Principal Act is amended by adding at the end thereof the following subsection:—
- "(5) The regulations may provide for and regulate the supply by the Department of books and materials to children attending schools other than State schools, and may prescribe the cases in which, and the conditions under which, books and materials may be so supplied without charge.".
