AMENDMENTS OF THE LOCAL GOVERNMENT ACT 1962

AN ACT to amend the *Hospitals Act 1918*, the *Constitution Act 1934*, and the *Local Government Act 1962* consequential upon the enactment of the *Electoral Act 1985*.

[Royal Assent 12 June 1985]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Electoral (Consequential Amendments) Act 1985*. Short title.

Commencement. **2**—This Act shall commence on the day fixed under section 2 (3) of the *Electoral Act* 1985.

Amendment of the *Hospitals Act* 1918. **3**—Schedule 2 to the *Hospitals Act* 1918* is amended by omitting from clause 8 (4) (a) “ section 119 of the *Electoral Act* 1907 ” and substituting “ section 129 of the *Electoral Act* 1985 ”.

Amendments of the *Constitution Act* 1934. **4**—Each provision of the *Constitution Act* 1934† specified in column 1 of Schedule 1 is amended in the manner specified opposite the reference to that provision in column 2 of that Schedule.

Amendments of the *Local Government Act* 1962. **5**—Each provision of the *Local Government Act* 1962‡ specified in column 1 of Schedule 2 is amended in the manner specified opposite the reference to that provision in column 2 of that Schedule.
