WESTBURY AND HAGLEY WATER.

AN ACT to amend the Westbury and Hagley Water Act 1898. [15 December, 1948.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1—(1) This Act may be cited as the Westbury and Short title Hagley Water Act 1948.
- (2) The Westbury and Hagley Water Act 1898*, as subsequently amended, is in this Act referred to as the Principal Act.
 - 2 In this Act, unless the contrary intention appears—
 "the Council" means the Council of the Municipality
 of Westbury:
 - "the Corporation" means the Warden, Councillors and Electors of the Municipality of Westbury.
- **3** It shall be lawful for the Council, on behalf of the Borrowing Corporation, in addition to any moneys already borrowed under the Principal Act to borrow under and in accordance with the provisions of the *Local Bodies Loans Act* 1881† such sums of money, not exceeding in the whole the sum of £20,000, for the purposes of the Principal Act and of defraying the costs and expenses of and incidental to the preparation and passing of this Act.
