

- (b) by omitting subsection (4) and substituting therefor the following subsection:—

“(4) No permit granted under this section authorizing the holding of a motor-vehicle race, elsewhere than on any land (whether above or below high-water mark) which forms, or forms part of, the beach or shore of the sea or any tidal waters, shall be of any effect unless there is in force in relation to that race a policy of insurance that complies with the requirements of this section.”;

- (c) by omitting from subsection (5) the words “or reliability trial” (twice occurring) and the words “or trial” (twice occurring);

- (d) by omitting sub-paragraph (b) of paragraph 1 of subsection (6) and substituting therefor the following sub-paragraphs:—

“(b) Fifty thousand pounds in respect of all claims arising out of the same accident in respect of the death of, or bodily injury to, more persons than one: or

“(c) Fifty thousand pounds in respect of all claims arising out of the same accident in respect of damage or injury to property: or”; and

- (e) by omitting from subsection (7) the words “or reliability trial”.

EXTON WATER.

No. 11 of 1959.

AN ACT to amend the *Exton Water Act* 1947.

[6 August 1959.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Exton Water Act* 1959. Short title and citation.

(2) The *Exton Water Act* 1947, as subsequently amended, is in this Act referred to as the Principal Act.

2 The Principal Act is amended by omitting the schedule thereto and substituting therefor the following schedule:—

“ THE SCHEDULE.

“(Section 2.)

“ EXTON WATER AREA.

“Commencing at the municipal boundary between Westbury and Deloraine municipalities on the Meander River and by that boundary line southerly for a distance of 222½ chains to the south-eastern corner of 284 acres purchased by A. H. Badcock thence easterly by the southern boundary of that land for a distance of 45 chains thence northerly for a distance of 8½ chains thence easterly along the southern boundary of 321 acres purchased by P. H. Martin for a distance of 14 chains thence southerly for a distance of 9½ chains thence easterly to and crossing the Exton to Osmaston Road for a distance of 36½ chains to the south-eastern corner of 61½ acres of land purchased by Mrs. J. O'Reilly thence southerly for a distance of 18 chains to the south-western corner of 144 acres purchased by E. A. S. Atkins thence easterly for a distance of 20 chains to the south-eastern corner of 144 acres purchased by E. A. S. Atkins thence southerly and by the western boundary of 300 acres purchased by E. G. Young for a distance of 43½ chains to Quamby's Brook thence by that brook to the eastern boundary of 390 acres purchased by Mrs. A. Arthur Hart thence northerly for a distance of 73½ chains thence easterly for a distance of 18 chains to Berresford Lane thence southerly by that lane for a distance of 18 chains thence easterly for a distance of 76 chains thence northerly for a distance of 42 chains to the Bass Highway thence westerly by that highway for a distance of 38 chains to 335 acres purchased by James Henry Lyne thence northerly by the eastern boundary of that land to the Meander River thence by that river westerly to the point of commencement.”.

AN ACT to amend the *Audit Act* 1918.

[6 August 1959.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Audit Act* 1959.

(2) The *Audit Act* 1918, as subsequently amended, is in this Act referred to as the Principal Act.

(3) This Act shall be deemed to have commenced on the first day of July 1958.

2 Section five of the Principal Act is amended by omitting from subsection (1) thereof the word “two” and substituting therefor the word “five”.
