#### FORESTRY AMENDMENT ACT 1981

No. 18 of 1981

AN ACT to amend the Forestry Act 1920 to provide for assistance with respect to the establishment, development, and proper management of a scheme for the planting of trees for purposes other than private forestry, and to make further provision with respect to the permanent head of the Forestry Department and

the employment of officers and other persons in that department.

[Royal Assent 6 May 1981]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:——

- 1—This Act may be cited as the Forestry Amendment Act 1981. Short title.
- **2**—In this Act, the *Forestry Act* 1920\* is referred to as the Principal Act. Principal Act.

Substitution of section 10 of Principal Act.

**3**—Section 10 of the Principal Act is repealed and the following section is substituted:—

Appointment of officers, &c.

- 10—(1) The Governor may, subject to the provisions of the *Public Service Act* 1973, appoint such persons as officers of the Department as may be necessary for the administration of this Act.
- (2) The Commission may appoint and employ any person on a casual, temporary, or part-time basis for the purposes of carrying out work in the Department, other than work of a clerical or administrative nature, and may dismiss any such person.
- (3) Any person appointed by the Commission under subsection (2) is not subject to the provisions of the *Public Service Act* 1973.
- (4) For the purposes of the *Public Service Act* 1973, the Chief Commissioner shall be deemed to be the permanent head of the Department and shall have the same powers and authority in relation to that Department as if he were an officer under that Act.
- (5) An officer of the Department who is appointed under subsection (1) and in respect of whom the Governor declares under section 5 (1) (p) of the *Public Service Act* 1973 that the provisions of that Act shall not apply—
  - (a) shall be employed by the Commission on such terms and conditions as it may determine; and
  - (b) retains his existing and accruing rights in respect of leave of absence on account of sickness, long-service leave, and superannuation as if his employment by the Commission were a continuation of his service as an officer under that Act.
- 4—After Part IIA of the Principal Act, the following Part is inserted:—

## SCHEME FOR PLANTING OF TREES FOR PURPOSES OTHER THAN PRIVATE COMMERCIAL FORESTRY

120—(1) The Commission may render advice and assist-commission ance to any person with respect to the establishment, developmay render

ment, and proper management of a scheme for the planting of
tree planting. trees for such purposes, other than private commercial forestry, as the Commission may from time to time determine.

- (2) Where the Commission renders any advice or assistance under subsection (1) it may impose such charges for the rendering of that advice or assistance as may be agreed between the Commission and the person to whom that advice or assistance is rendered.
- (3) The Commission shall cause any payment received by it pursuant to subsection (2) to be credited to the Forestry Fund.
- 12R—(1) The Commission, with the approval of the Financial Treasurer, may enter into and carry into effect agreements for rendering financial assistance for the purpose of assisting the establishment, development, and proper management of a scheme for the planting of trees for such purposes, other than private commercial forestry, as the Commission may from time to time determine.

(2) Financial assistance under this section shall be rendered on such terms and conditions as are determined by the Commission.

12s—(1) The expenses of the Commission under section Expenses of 12R shall be paid out of money provided by Parliament for that purpose, and any revenue received by the Commission under that section shall be paid into the Consolidated Revenue.

(2) The Commission may receive funds from any source for the purpose of their application for any purposes of this Part and may so apply any such funds.

Section 5

Consequential amendments of Principal Act.

**5**—The Principal Act is amended in the manner specified in Schedule 1.

Transitional provisions.

**6**—A person who immediately before the commencement of this Act is appointed and employed under section 10 of the Principal Act shall, on the commencement of this Act, be deemed to have been appointed and employed under that section as substituted by section 3 of this Act.
