A.D. AN ACT to amend the Food and Drugs Act 1910. [17 June, 1941.] 1941

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:---

- 1 This Act may be cited as the Food and Drugs Act 1941. Short title.
- 2 Section sixty of the Principal Act is hereby amended -- Amendment
 - I. By adding at the end of paragraph III. thereof the No. 22, s. 60. words "and regulating the method of manufacture, preparation, or storage of specified foods and drugs, and providing for the licensing of manufacturers and other persons in relation to specified

foods or drugs:" and by inserting after that paragraph the following new paragraphs IIIA. and IIIB.—

- "IIIA. Prescribing the methods and precautions to be adopted for the purpose of the protection of foods and drugs from contamination, including the conditions of manufacture, preparation, storage, packing, sale, delivery, and carriage of foods and drugs, the construction and equipment of premises and vehicles in which foods or drugs are manufactured, sold, packed, kept, or transported, and the facilities to be provided in such premises for securing cleanliness:
- "IIIB. Prescribing the provisions for securing cleanliness and freedom from contamination to be complied with in respect of shops, hotels, boarding and lodging houses, restaurants, and all places where food is sold or meals are provided:": and
- II. By inserting after paragraph x. thereof the following new paragraphs xA. and xB.—
 - "XA. Prohibiting the use, in labels attached to articles of food or drugs, of false or misleading claims, statements, words, or devices as to the contents of packages or the ingredients, composition, strength, quality, or medicinal or food values of articles of food or drugs, and regulating and controlling the contents of labels or advertisements relating to drugs and medicines, and prohibiting the use in such labels or advertisements of words, statements, or claims indicating or suggesting that such drugs or medicines may be used as remedies for specified diseases:
 - "XB. Requiring the proprietor, manager, or person in charge of any premises where any food or drug is manufactured, prepared, stored, sold, or deposited for sale, to display conspicuously therein a copy of such regulations made under this Act as may be directed by an inspector."
