AN ACT to amend the Fruit Board Act 1934. [26 June 1958.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

- 1—(1) This Act may be cited as the Fruit Board Act 1958.
- (2) The Fruit Board Act 1934, as subsequently amended, is in this Act referred to as the Principal Act.

Constitution of Board.

- 2 Section four of the Principal Act is amended—
 - (a) by omitting subsections (4) and (5) and substituting therefor the following subsections:—
 - "(4) The term of office of a member of the Board commences on the day following the day appointed for the periodical election at which he is elected and ends on the day appointed for the third periodical election after that at which he is elected.
 - "(5) At each periodical election the three members who have been longest in office without re-election shall retire."; and
 - (b) by inserting in subsection (7), after the word "office" (second occurring), the words "without re-election".

Nominations.

3 Section eleven of the Principal Act is amended by omitting from subsection (2) the words "day and hour appointed for receiving nominations" and substituting therefor the words "twenty-eighth day before the day appointed".

Election of

- 4 Section twelve of the Principal Act is amended—
 - (a) by omitting subsections (1), (2), (3), and (4) and substituting therefor the following subsection:—
 - "(1) Periodical elections for the election of members of the Board shall be held on the first Friday in the month of July in each year.":
 - (b) by omitting from subsection (5) the word "so" (first occurring), and inserting in that subsection, after the word "officer", the words "at an election";

- (c) by omitting from subsection (6) the words ", at such time and";
- (d) by omitting subsection (7); and
- (e) by omitting from subsection (9) the words ", and periodical elections shall be held every year".

AUDIT.

No. 7 of 1958.

AN ACT to amend the *Audit Act* 1918. [26 June 1958.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the Audit Act 1958.

Short title, citation, and commencement

- (2) The Audit Act 1918, as subsequently amended, is in and commencement this Act referred to as the Principal Act.

 (3) This Act shall be deemed to have commenced on the
- first day of July 1957.
- 2 Section five of the Principal Act is repealed and the following section is substituted therefor:—
- "5—(1) The Auditor-General shall be paid a salary at the Salary of rate of three thousand two hundred pounds a year.

 Salary of Auditor-General.
- (2) The salary of the Auditor-General shall be paid out of the Consolidated Revenue which, to the necessary extent, is appropriated accordingly.
- (3) No addition to, or deduction from, the salary payable pursuant to this section shall be made in order to meet variations in the cost of living.".
