

“(5) The Council shall not in any report made to the Minister under this Act disclose—

(a) any information with respect to any process, plant, or equipment used in the business carried on by any particular person; or

(b) any information with respect to the financial affairs of any particular person, without the consent of that person.”.

**3** After section ten of the Principal Act the following section is inserted:—

Protection of members, officers, &c.

“10A. A member of the Council, the secretary of the Council, any officer appointed under section five, and any authorized officer is not personally liable, and the Crown is not liable, in respect of any statement made or issued, or any act done, in good faith for the purpose of the carrying out of any functions under this Act.”.

## FARMERS' DEBT ADJUSTMENT.

---

No. 73 of 1971.

AN ACT to amend the *Farmers' Debt Adjustment Act 1936*. [26 November 1971.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

**1**—(1) This Act may be cited as the *Farmers' Debt Adjustment Act 1971*.

(2) The *Farmers' Debt Adjustment Act 1936*, as subsequently amended, is in this Act referred to as the Principal Act.

**2** After section forty-seven of the Principal Act the following section is inserted:—

“ 47A Notwithstanding anything in section forty-seven or in the *Public Account Act 1957*, the Treasurer may—

Additional purposes for which certain moneys may be applied.

- (a) out of the moneys that, at the commencement of this section, are standing to the credit of the account referred to in section forty-seven, apply the sum of two hundred and eighty-eight thousand dollars for the purpose of reimbursing the Loan Fund in respect of loans made out of that Fund to eligible persons under the *Primary Producers' Relief Act 1968*; and
- (b) advance to the Rural Reconstruction Board for the purposes of the *Rural Reconstruction Act 1971* a sum not exceeding two hundred and eighty-eight thousand dollars out of the moneys paid to the Treasurer after the commencement of this section in pursuance of section ten of the *Primary Producers' Relief Act 1968*.”.

## DANGEROUS DRUGS (No. 2).

### No. 74 of 1971.

AN ACT to amend the *Dangerous Drugs Act 1959*.

[26 November 1971.]

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—(1) This Act may be cited as the *Dangerous Drugs Act (No. 2)* 1971. Short title and citation.

(2) The *Dangerous Drugs Act 1959*, as subsequently amended, is in this Act referred to as the Principal Act.
