FINANCIAL INSTITUTIONS (MISCELLANEOUS AMENDMENTS) ACT 1996

No. 62 of 1996

An Act to amend the Acts Interpretation Act 1931 and certain Acts so as to permit persons whose financial arrangements or investment powers are regulated by Tasmanian legislation to use the financial services offered by building societies and credit unions

[Royal Assent 16 December 1996]

Be it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

Short title

1. This Act may be cited as the Financial Institutions (Miscellaneous Amendments) Act 1996.

Commencement

2. This Act commences on a day or days to be proclaimed.
