AN ACT to authorise the Public Trustee to pay to the Treasurer certain moneys in his hands, being the balance of the proceeds of the sale of certain land at St. Helens devised by the late Father *Martial Louis Frederic Mary*, formerly of Campbell Town, Roman Catholic Priest, for certain charitable purposes at St. Helens, together with certain other moneys, and to provide for the application of such moneys towards the establishment or maintenance of a Bush Nursing Hospital at St. Helens. WHEREAS by his will, dated the eighth day of December, Preamble.
one thousand eight hundred and eighty-seven, *Martial Louis Frederic Mary*, formerly of Campbell Town in this State, Roman Catholic Priest, devised certain land at St. Helens upon trust for certain charitable purposes:

Father Mary's Charity (Disposal).

A.D. 1941. — And whereas, by an order (in this Act referred to as "the said order") of His Honour Mr. Justice *Crisp*, dated the second day of November, one thousand nine hundred and thirty-four, it was ordered that the said land should be vested in the Public Trustee upon trust to sell the same and to pay the proceeds of the sale, together with certain other moneys, subject to certain conditions specified in the said order, to the Warden, Councillors, and electors of the Municipality of Portland to be applied by them in the erection of a hospital at St. Helens:

And whereas the proceeds of the sale of the said land, together with the other moneys, proved insufficient to provide for the erection of a hospital as directed by the said order:

And whereas it is desirable to make provision for the application of the moneys held by the Public Trustee pursuant to the said order:

And whereas the Council of the said Municipality are desirous that the said moneys should be applied towards the establishment or maintenance of a Bush Nursing Hospital at St. Helens:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title. **1** This Act may be cited as *Father Mary's Charity (Disposal) Act 1941*.

Power to Public Trustee to pay moneys to Treasurer. **2** The Public Trustee may pay to the Treasurer all moneys in his hands representing the proceeds of the sale of the land referred to in the said order, and all other moneys held by him on account of the estate of the said *Martial Louis Frederic Mary*.

Application of moneys. **3** The said moneys shall be paid and credited to a deposit account to be kept in the books of the Treasurer, and shall be applied towards the establishment or maintenance of a Bush Nursing Hospital at St. Helens.
