 SCHEDULE 1—AMENDMENT OF SPECIFIED ACTS

AN ACT to amend certain enactments in consequence of the enactment of the Forest Practices Act 1985.

[Royal Assent 23 May 1985]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the Forest Practices (Miscellaneous short title. Amendments) Act 1985.

Commencement. 2—This Act shall commence on the same day as that fixed by proclamation under section 2 (2) of the Forest Practices Act 1985.

Amendment of specified Acts.

3—Each Act specified in column 1 of Schedule 1 is amended in the manner specified in column 2 of that Schedule.
