## AN ACT to amend penalties contained in the Fire Service Act 1979

# [Royal Assent 23 December 1993]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

#### Short title

1—This Act may be cited as the Fire Service Amendment (Penalties) Act 1993.

#### s. 2 No. 101

#### Commencement

2—This Act commences on the day on which it receives the Royal Assent.

## Principal Act

3—In this Act, the Fire Service Act 1979\* is referred to as the Principal Act.

# Amendment of penalties

4—Each provision of the Principal Act listed in Column 1 of Schedule 1 is amended by omitting the penalty specified in Column 2 and substituting the penalty specified in Column 3.
