# AN ACT to amend the Fire Service Act 1979

# [Royal Assent 20 April 1993]

 $\mathbf{B}^{\mathrm{E}}$  it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

### Short title

1-This Act may be cited as the Fire Service Amendment (Membership of Commission) Act 1993.

#### Commencement

2-This Act commences on the day on which it receives the Royal Assent.

### **Principal Act**

3—In this Act, the *Fire Service Act* 1979<sup>\*</sup> is referred to as the Principal Act.

### Section 7 amended (State Fire Commission)

4-Section 7 of the Principal Act is amended as follows:-

- (a) by inserting in subsection (3) the following paragraphs after paragraph (b):—
  - (ba) a person appointed on the nomination of the United Fire Fighters Union (Tasmanian Branch);
  - (bb) a person appointed on the nomination of the State Urban Volunteer Firefighters Association;
  - (bc) a person appointed on the nomination of the Tasmanian Country Fire Brigades Association;
- (b) by inserting in subsection (5) ", (ba), (bb), (bc)" after "(b)";
- (c) by inserting in subsection (6) "(ba), (bb), (bc) or" after "paragraph" (first occurring);
- (d) by inserting after subsection (6) the following subsections:—

(6A) If a body referred to in paragraph (ba), (bb), (bc) or (c) of subsection (3) changes its name, the Governor may, by order, amend that paragraph by substituting the body's new name.

(6B) If a body referred to in paragraph (ba), (bb), (bc) or (c) of subsection (3) ceases to exist, the Governor may, by order, amend that paragraph by substituting the name of a body which the Governor is satisfied substantially represents the interests represented by the first-mentioned body.
