

## NURSES' REGISTRATION.

No. 30 of 1962.

AN ACT to amend the *Nurses' Registration Act*  
1952. [1 October 1962.]

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title  
and citation.

**1**—(1) This Act may be cited as the *Nurses' Registration Act* 1962.

(2) The *Nurses' Registration Act* 1952, as subsequently amended, is in this Act referred to as the Principal Act.

Registration  
of nurses.

**2** Section ten of the Principal Act is amended by inserting after paragraph (c) of subsection (1) the following paragraph:—

“(ca) mental deficiency nurse;”.

Qualifications  
for

**3** Section eleven of the Principal Act is amended—

- (a) by inserting in sub-paragraph (i) of paragraph (a) of subsection (1), after the word “nurse”, the words “or a mental deficiency nurse”;
- (b) by inserting in sub-paragraph (iii) of that paragraph, after the word “nurse” the words “or a mental deficiency nurse”; and
- (c) by inserting after that sub-paragraph the following sub-paragraph:—

“(iiiA) mental deficiency nursing, has attended the practice, lectures, and training of an institution for the care of persons who are mentally deficient that is an approved training institution for a period of not less than three years; or, if registered as a general nurse or a psychiatric nurse, for a period of not less than twelve months;”.

## GUEST HOUSES REGISTRATION.

No. 31 of 1962.

AN ACT to amend the *Guest Houses Registration Act* 1937. [1 October 1962.]

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—(1) This Act may be cited as the *Guest Houses Registration Act 1962*. Short title and citation.

(2) The *Guest Houses Registration Act 1937*, as subsequently amended, is in this Act referred to as the Principal Act.

**2** Section two of the Principal Act is amended by inserting in paragraph (a) of the definition of "guest house", after the word "providing", the words "lodging or both". Interpretation.

**3** Section four of the Principal Act is amended by inserting in paragraph (a) of subsection (6) thereof, after the word "with" (first occurring), the words "lodging or, as the case may be, with". Registration of guest houses.

**1**—(1) This Act may be cited as the *Tasmanian Orchestra (Continuation) Act 1962*. Short title and citation.

(2) The *Tasmanian Orchestra (Continuation) Act 1951*, as subsequently amended, is in this Act referred to as the Principal Act.

**2** Section three of the Principal Act is amended by omitting therefrom the numerals "1963" and substituting therefor the numerals "1966". State contribution.
