AN ACT to validate certain resolutions passed by the Council of the Municipality of Glenorchy providing for certain contributions by the Council towards the cost of construction of certain Private Streets in the Municipality. [21 December, 1939.] 1939

WHEREAS the Council of the Municipality of Glenorchy Preamble. (in this Act referred to as "the Council"), by special resolutions (in this Act referred to as "the said resolutions") passed on the second day of July, one thousand nine hundred and twenty-nine, the second day of September, one thousand nine hundred and thirty, the twelfth day of December, one thousand nine hundred and thirty-three, and the sixteenth day of January, one thousand nine hundred and thirty-four, respectively, resolved that a contribution should be made by the

Glenorchy Private Streets.

Council out of the General Account of the Municipality towards the cost of the construction of the private streets in the Municipality comprised in the said resolutions and set forth in the schedule, and that such contribution should be a sum equal to one-third of the cost of the construction thereof:

And whereas the Council, in passing the said resolutions, purported to act in pursuance of the provisions of the Town Roards Act 1896.

And whereas the said resolutions were in excess of the powers conferred on the Council by the said Act:

And whereas it is desirable to validate the said resolutions and all payments made or to be made in pursuance thereof:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:--

1 This Act may be cited as the Glenorchy Private Streets $Ac\bar{t}$ 1939.

- **2**—(1) The said resolutions are hereby validated.
- (2) All payments made (whether before or after the commencement of this Act), pursuant to the said resolutions, shall be deemed to have been, or to be, lawfully and validly made.

THE SCHEDULE.

The following streets, so far as the same were constructed as private streets under the *Town Boards Act* 1896, pursuant to the said resolutions-

- I. Garden-road, Central-avenue, Bay-road, Bayswater-road, Reid-street, Pierce-street, Orchard-road, Gormanston-road, Hopkinsstreet, and View-street, in the Town of Moonah:
 II. Albert, Windsor, and Knoll Streets in the Town of Glenorchy.
