- (2) Any payments which the Minister agrees to make under this section, and which the Treasurer determines not to have the nature of revenue expenditure, shall be made out of moneys borrowed under section nine of this Act.
- **9** The Treasurer may borrow the sum of £25,000 and such Borrowing-other sums as Parliament may hereafter approve and may apply the same for the purpose of meeting:—
  - (a) compensation payable under section two and other costs of and incidental to the resumption thereby provided;

(b) the cost of and incidental to the reclamation of land under section three;

(c) the cost of preparing the land for use as provided in section four, including the initial cost of roads, paths, drains, and similar things required for the proper use of the land;

(d) sums payable to the Transport Commission under

section seven; and

(e) payments out of borrowed moneys under section eight.

### No. 33 of 1951.

# AN ACT to consolidate and amend the Governor's Salary Acts.

[Reserved, 13th April 1951; Royal Assent proclaimed, 27th June, 1951.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1—(1) This Act may be cited as the Governor's Salary Short title and Act 1951.
- (2) The Governor's Salary Act 1887\* and the Governor's Salary Act 1927† are repealed.
- 2 There shall be payable to the Governor of the State, while Governor's he holds office, a salary, at the rate of three thousand pounds 18 Geo. v. No. per annum, out of the Consolidated Revenue, which, to the 108, s. 3. necessary extent, is hereby appropriated accordingly.

**3**—(1) An officer appointed to be Governor of Tasmania shall receive an allowance equal to the Governor's salary from the date at which he embarks to assume the Government, whether the port of embarkation be in Great Britain or in another State or elsewhere.

Governor's Salary.

(2) An allowance under this section shall be paid out of the Consolidated Revenue, which, to the necessary extent, is hereby appropriated accordingly.

Termination of salary.

4 Subject to the provision of the necessary moneys by Parliament, an allowance equal to the Governor's salary may be paid to a former Governor from the time he ceases to hold office for so long as the provision made by Parliament extends.

- 5—(1) An officer provisionally administering the Government of Tasmania during the absence or incapacity of the Governor, or during a vacancy of the office, shall receive a salary at the rate of fifteen hundred pounds per annum.
- (2) A salary under this section shall be paid out of the Consolidated Revenue, which, to the necessary extent, is

hereby appropriated accordingly.

Staff of administrator.

6 An officer so administering the Government may appoint Cf. ibid., s. 6. the same staff as a Governor, and any moneys payable out of the Consolidated Revenue to or in respect of the staff of a Governor shall be similarly payable to or in respect of the staff of such an officer.

AN ACT to appropriate and apply a sum from the Consolidated Revenue for an allowance to the Governor.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:--

Short title.

**1** This Act may be cited as the Appropriation (Governor's Allowance) Act 1951.

Appropriation.

2 The Consolidated Revenue Fund is hereby appropriated to the extent necessary to pay to His Excellency the Governor now in office an allowance under section four of the Governor's Salary Act 1951 from the time he ceases to hold office until the thirtieth day of September, 1951.
