## KINGBOROUGH WATER.

## No. 17 of 1949.

AN ACT to amend the Kingborough Water Act 1941. [12 April, 1949.]

B<sup>E</sup> it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

- 1—(1) This Act may be cited as the Kingborough Water Act 1949.
- (2) The Kingborough Water Act 1941\*, as subsequently amended, is in this Act referred to as the Principal Act.

Commencement. 2 This Act shall be deemed to have commenced on the date of the commencement of the Principal Act.

Power to borrow. 3 Section six of the Principal Act is amended by omitting the words "seven thousand seven hundred pounds" and inserting in their stead the words "seventeen thousand seven hundred pounds".

## GLENORCHY WATER.

## No. 18 of 1949.

AN ACT to amend the Glenorchy Water Act 1890. [12 April, 1949.]

B<sup>E</sup> it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as the Glenorchy Water Act 1949.

2 Section fifty-nine of the Glenorchy Water Act 1890\* Supply of is amended by adding at the end thereof the following sub-water for other purposes than section :=

domestic use.

- "(2) Notwithstanding anything contained in section two hundred and seventeen of the Local Government Act 1906; or in section seven of the Glenorchy Water Act 1911; or in this section, the trustees may, if they think fit, enter into an agreement in writing with any person carrying on any trade, manufacture, or business within the water district who requires or will customarily consume not less than one hundred and twenty million gallons of water in each year, for the supply of water to such person for such period as may be specified in the agreement, on and subject to—
  - I. The payment by such person in respect of all water supplied to such person in pursuance of the agreement--
    - (a) in respect of the first one hundred and twenty million gallons supplied in each year, at a price or prices by measure which is not less than the price or prices charged from time to time for water supplied or to be supplied by measure by the Council to other persons: and
    - (b) in respect of all water supplied in pursuance of the agreement in excess of one hundred and twenty million gallons in each year, at such price or prices, or subject to such rebates and allowances (if any) in respect of the whole or any part of such excess, as may be specified in the agreement: and
  - II. Such other terms and conditions as may be specified in the agreement:

Provided that no agreement under this subsection shall have any force or effect unless and until it has been submitted to and approved by the Administrator constituted under the Southern Regional Water Supply Act 1946§.".
