AN ACT to amend the *Hobart Bridge Act 1936*.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as the *Hobart Bridge Act 1937*. Short titl.

2 The Principal Act is hereby amended—

- I. By deleting the words “December” and “thirty-seven” in the second and third lines of paragraph 1. of subsection (1) of section two thereof and substituting therefor the words “May” and “thirty-eight” respectively : and

- (a) By expunging subsections (2) and (3) and renumbering subsection (4) as (2):
- (b) By deleting the words “and upon” to “Revenue” in the last lines of subsection (2) as so renumbered and inserting thereafter the following new subsection (3)—

“(3) When the aggregate of the amounts standing to the credit of the sinking fund established as provided by subsection (1), and of the depreciation fund provided under subsection (2) hereof respectively, reaches the sum of three hundred and seventy-three thousand pounds, the same shall be paid, upon the certificate of the Director, that the bridge is structurally sound and in a satisfactory state of repair, to the Company, and thereupon the franchise granted to the Company under this Act shall cease and determine.”.
