ROADS AND JETTIES.

No. 85 of 1971.

AN ACT to amend the *Roads and Jetties Act* 1935. [14 December 1971.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

- **1**—(1) This Act may be cited as the Roads and Jetties Act 1971.
- (2) The Roads and Jetties Act 1935, as subsequently amended, is in this Act referred to as the Principal Act.

State Highways Trust Fund.

- 2 Section four of the Principal Act is amended—
 - (a) by omitting paragraph (b) of subsection (2) and substituting therefor the following paragraph:—
 - "(b) a sum equal to the amount of the motor taxes collected in each financial year and paid to the Treasurer as required by paragraph (a) of subsection (3) of this section;"; and
 - (b) by inserting in sub-paragraph (i) of paragraph (a) of subsection (3), after the word "taxes", the words "(after the deduction therefrom of the sums referred to in paragraph (c) of subsection (7) of this section and of the refunds made pursuant to paragraph (e) of subsection (1) of section nine of the Transport Act 1938)".

HOBART CORPORATION.

No. 86 of 1971.

AN ACT to amend the *Hobart Corporation Act* 1963. [14 December 1971.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

- 1—(1) This Act may be cited as the *Hobart Corporation Act* 1971.
- (2) The Hobart Corporation Act 1963, as subsequently amended, is in this Act referred to as the Principal Act.

- 2 After section two hundred and twenty-eight of the Principal Act the following section is inserted:—
- "228A—(1) For the purpose of providing a place for the sale Salamanca of goods and for entertainment the corporation may—

 Market.
 - (a) after giving at least five days' notice of its intention so to do in a newspaper published in the city, close part of Salamanca Place on one or more Saturdays between the first day of November in any year and the second Saturday in March in the following year for not more than eight hours on any one Saturday;
 - (b) subject to subsection (2), enter into occupation of, and exercise all the rights of an owner over, the part so closed, and in particular but without limiting the generality of this paragraph—
 - (i) give permission in writing to occupy portions of that part at such times, for such purposes, and on such conditions as it thinks fit; and
 - (ii) charge for giving such permission;
 - (c) provide and use or hire stalls, stands, pens, signs, fences, and other structures; and
 - (d) by resolution of the council, empower officers of the corporation to take any action required for the purposes of this section or to control the part so closed.
- "(2) The corporation shall give reasonable means of access to their lands to frontagers on the part so closed, who may use such means of access for themselves, persons doing anything on their lands, and vehicles and machinery that they require to enter or leave their lands.
- "(3) The corporation may make by-laws for the purposes of this section and, in particular and without limiting the generality of this subsection for regulating—
 - (a) conduct in;
 - (b) sales and entertainment in; and
 - (c) admission to,

the part so closed.".
