

HYDRO-ELECTRIC COMMISSION (POWER DEVELOPMENT).

No. 30 of 1967.

AN ACT to authorize the construction of certain works by the Hydro-Electric Commission.

[1 September 1967.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and incorporation.

1—(1) This Act may be cited as the *Hydro-Electric Commission (Power Development) Act 1967*.

(2) This Act is incorporated, and shall be read as one, with the *Hydro-Electric Commission Act 1944*.

Construction of works.

2 The construction and carrying out by the Commission of the works and purposes specified in the schedule are authorized subject to the provisions of the *Public Account Act 1957*.

Expenses of construction of works.

3 The expenses of and incidental to the construction and carrying out of the works and purposes specified in the schedule shall not exceed—

- (a) in the case of the works and purposes specified in Part I thereof, the sum of \$95,000,000.00; and
- (b) in the case of the works and purposes specified in Part II thereof, the sum of \$20,750,000.00.

THE SCHEDULE.

PART I.

GORDON RIVER POWER DEVELOPMENT, STAGE I.

Works connected with a new hydro-electric power development to be situated in the south-west of Tasmania upstream of the junction of the Gordon River and Serpentine River, to be known as the Gordon River Power Development Stage I, including the construction of dams, canals, tunnels, pipelines, conduits, bridges, roads, and other works connected with the conservation of the waters of the Gordon River, the Serpentine River and the Huon River and their tributaries and their diversion to the power station of that power development, the construction of that power station, the purchase and installation of generating plant, transformers, and other electrical, hydraulic, pumping, and

mechanical equipment, the acquisition and inundation of land (including easements) for those purposes, and the provision of any other works, roads, camps, villages, housing and services, and equipment incidental thereto and required in connection with the new power development.

PART II.

THERMAL POWER STATION.

Works connected with a new power development, being a thermal power station to be situated on the eastern shore of the River Tamar in the vicinity of George Town, including the construction of that power station, the purchase, construction, and installation of boilers, condensers, generating plant, transformers, and other hydraulic, mechanical, pumping and electrical equipment, fuel storage facilities and fuel handling plant, moorings, jetties, circulating water conduits and other facilities, the construction and laying of pipelines, the abstraction and return of water to the River Tamar, the acquisition of land (including easements) for those purposes, and the provision of any other works, camps, housing and services, and equipment incidental thereto and required in connection with the new power development.

HYDRO-ELECTRIC COMMISSION.

AN ACT to amend the *Hydro-Electric Commission Act 1944* and to extinguish a highway.

[22 September 1967.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Hydro-Electric Commission Act 1967*. Short title and citation.

(2) The *Hydro-Electric Commission Act 1944*, as subsequently amended, is in this Act referred to as the Principal Act.
