immediately before his death, retirement, resignation, or dismissal and had continued to be entitled to the salary attaching to that employment."; and

(e) by omitting subsection (6).

Right of employee to elect to retire in certain cases.

- 6 Section eight of the Principal Act is amended-
  - (a) by omitting from subsection (1) the words "as from the date upon which the leave of absence under this Act, if granted to him, would have commenced";
  - (b) by inserting in that subsection, after the words "been granted to him", the words "for a period commencing on such day as he may specify in his election";
  - (c) by inserting, after subsection (3A), the following subsection:—
    - "(3AB) For the purposes respectively of subsection (1) and of subsection (3) of this section the leave of absence to which an employee is entitled shall be reckoned as the leave of absence under this Act to which he would have been entitled at the end of the period of leave of absence referred to in the subsection if he had continued in his employment until the end of that period."; and

(d) by omitting from subsection (3B) all the words following the word "vacant" and substituting therefor the words "immediately before the commencement of the period of leave of absence referred to in subsection (1) or subsection (3)

of this section, as the case may be.".

- (2) For the purposes of this section, the basic rate is—
  - (a) the sum of one thousand seven hundred and ninetyfour dollars a year; or
  - (b) the sum ascertained, to the nearest dollar, in accordance with the prescribed formula.
- (3) For the purposes of this Act, the Government Statistician shall, as soon as is practicable after the thirty-first day of March in each year, calculate the basic rate in respect of the period of twelve months ending on that day, and shall, without delay, report the result of his calculations to the Treasurer.
