'governing body' means the person who, or body of persons (whether incorporated or unincorporated) which, has the ownership, management, or control of a school.".

## KINGBOROUGH MUNICIPAL COMMISSION.

## No. 21 of 1967.

AN ACT to continue the Kingborough Municipal Commission and to validate its acts.

[24 July 1967.]

Preamble.

WHEREAS by a proclamation made and to take effect on the twentieth day of January 1960 commissioners were under section three of the Statutory Authorities Administration Act 1937 upon a report of the Auditor-General appointed to replace the council of the municipality of Kingborough and to exercise all the powers and functions of that council:

And whereas in the months of January 1961 and April 1963 the term of the commissioners was extended in accordance with subsection (9) of section three of that Act:

And whereas in the month of October 1964 the term of the commissioners was duly extended pursuant to subsection (1) of section forty of the *Local Government Act* 1962 for a further term of two years from the twentieth day of January 1965:

And whereas from the twentieth day of January 1967 no lawful municipal authority has existed for the municipality of Kingborough:

And whereas it is expedient to continue the commissioners' powers and to validate their acts on and since the twentieth day of January 1967:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and construction.

- 1—(1) This Act may be cited as the Kingborough Municipal Commission Act 1967.
- (2) This Act shall be read and construed subject to the Local Government Act 1962.

2 In this Act, unless the contrary intention appears, "Muni-Interprecipal Commission" means the commissioners appointed to replace the council of the municipality of Kingborough as hereinbefore recited and their successors in office.

- 3—(1) By virtue of subsection (3) of section two of the Extension Local Government Act 1962, the proclamation appointing the Commission. Municipal Commission—
  - (a) has effect as if it were a commission issued under section thirty-nine of that Act upon a report under paragraph (c) of subsection (1) of that section; and
  - (b) may have its term extended as provided in section forty of that Act.
- (2) The term of the Municipal Commission's commission is extended for a period of two years from the twentieth day of January 1967 as if both Houses of Parliament had agreed to a resolution for extending the term of that commission for that further period before the twentieth day of January 1967.
- 4 All things done by or in respect of the municipality of Validation Kingborough between the nineteenth day of January 1967 and commission's the commencement of this Act shall be deemed for all purposes acts. to be as valid and effectual as if the term of the Municipal Commission's commission had been extended pursuant to a resolution of both Houses of Parliament agreed to before the twentieth day of January 1967.

## BURNIE MARINE BOARD LOAN.

## No. 22 of 1967.

AN ACT to amend the Burnie Marine Board Loan Act 1936. [24 July 1967.]

RE it enacted by His Excellency the Governor of Tasmania. by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

- 1—(1) This Act may be cited as the Burnie Marine Board Short title and citation. Loan Act 1967.
- (2) The Burnie Marine Board Loan Act 1936, as subsequently amended, is in this Act referred to as the Principal Act.
- 2 Section three of the Principal Act is amended by omitting Authority to Board from subsection (1) the words "ten million" and substituting to borrow therefor the words "twenty million".
