Offences.

- 5 Section forty-six of the Principal Act is amended—
 - (a) by omitting from paragraph (d) of subsection (2) the words "the homestead called 'Watery Plains'" and substituting therefor the words "any intake which the Administrator may make in the vicinity of the village of White Hills in the County of Cornwall"; and
 - (b) by adding at the end of subsection (4) the words "and that River for a distance of two miles above any intake which the Administrator may make in the vicinity of the village of White Hillsin the County of Cornwall".

The Schedule. 6 The schedule to the Principal Act is amended by adding at the end thereof the following paragraph:—

"The works may, if the Minister thinks fit, include an auxiliary source of supply by pumping from the North Esk River near the village of White Hills in the County of Cornwall.".

LIBRARIES.

No. 59 of 1952.

AN ACT to amend the Libraries Act 1943. [2 December, 1952.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

- 1—(1) This Act may be cited as the Libraries Act 1952.
- (2) The Libraries Act 1943, as subsequently amended, is in this Act referred to as the Principal Act.

State aid.

- 2 Section nineteen of the Principal Act is amended—
 - (a) by omitting from subsection (4) the words "in subsection (5) hereof," and substituting therefor the words "by subsections (5) and (5A) of this section,"; and

- (b) by inserting after subsection (5) the following subsection:—
 - "(5A) Where the Board is satisfied, on the report of the State Librarian, that it is necessary or desirable so to do in order to ensure the proper equipment or development of any library, provided, controlled, and managed by a council under and in accordance with this Act (not being a library to which subsection (5) of this section applies) the Board may, in its discretion, determine that, for such period as the Board may fix, any State aid that may be granted to that council under this section shall consist of a cash subsidy of such amount as the Board may determine, either in addition to, or in substitution for, the loan of a collection of books, as provided by subsection (4) of this section."

PUBLIC WORKS EXECUTION (No. 2).

No. 60 of 1952.

AN ACT to provide for the execution and carrying out of certain public works and purposes, and to authorise the borrowing of certain sums of money, and the re-appropriation of certain unexpended moneys, for meeting the cost of those works and purposes, and for the purposes of the Transport Act 1938, and Hydro-Electric Commission Act 1944.
