AN ACT to amend the *Local Authorities Public Works Subsidies Act, 1936.* [1 April, 1937.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited as the *Local Authorities Public Works Subsidies Act, 1937.* Short title.

Local Authorities Public Works Subsidies.

2 The Principal Act is hereby amended—

I. As to section three thereof—

- (a) By inserting after the word “ which ” in the first line the words “ has constructed, is constructing or ” :
- (b) By inserting “ such ” (before “ plans ”) and “ as may be prescribed, to be approved by the Governor ” (after “ work ”) in subsection (2) :
- (c) By deleting the word “ proposed ” (first occurring in the second line), and “ as so ” to “ fit ” (in lines two and three) of subsection (3) :
- (d) By deleting from subsection (5)—
 - (i) “ proposed ” to “ authority ” (in the first and second lines) : and
 - (ii) “ to be borrowed ” and substituting “ raised ” :

II. By deleting from sections six and eleven thereof respectively—

- (a) “ proposed ” to “ authority ” (in the first two lines) : and
- (b) “ in such ” to “ approve ” (at the end), and substituting “ under the relevant provisions of the *Local Bodies Loans Act, 1881.* ”

III. By deleting from sections seven and twelve thereof respectively—

- (a) “ any such, ” and substituting “ an approved ” : and
- (b) “ not being later, ” to “ forty-five ” and substituting therefor in each case “ for a period of ten years ” :

IV. By deleting from section seven thereof—

- (a) “ as is ” to “ six ” : and
- (b) “ under that section, ” and substituting “ for the construction of a work which is proclaimed a public work for the purposes of this Part, or when a loan previously raised has been approved as provided by section six ” :

- V. By deleting from section twelve thereof— A.D. 1987.
- (a) “as is” to “eleven” : and
- (b) “under that section,” and substituting
“for the construction of a work which
is proclaimed a public work for the
purposes of this Part, or when a loan
previously raised has been approved as
provided by section eleven” :
- VI. By inserting “sections fourteen to twenty-four of” Section 15.
(before “the local” in section fifteen thereof) :
- VII. By inserting in section sixteen thereof— Section 16.
- (a) “(1)” at the commencement : and
- (b) “(2) The regulations may prescribe the
period within which instalment debentures
issued under this Act shall be
redeemable” (at the end).
