

6 The Board may reserve any part of the reclaimed land for streets or public places and may lay out, set up, and maintain those streets and public places, and all public conveniences in connection therewith, as the Board may think proper, and all costs and expenses thereby incurred by the Board shall be defrayed out of the funds of the Board. Reservation of streets, &c.

7 All moneys received by the Board under any demise of, or other dealing with, the reclaimed land shall be deemed to be funds at the disposal of the Board for the purposes of the Principal Act and may be applied by the Board accordingly. Application of certain moneys.

AN ACT to amend the *Landlord and Tenant Act* 1949. [14 April, 1954.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Landlord and Tenant Act* 1954. Short title, citation, and commencement.

(2) The *Landlord and Tenant Act 1949*, as subsequently amended, is in this Act referred to as the Principal Act.

(3) This Act shall be deemed to have commenced on the twenty-ninth day of March 1954.

Expiry of Act.

2 Section eighty-eight of the Principal Act is amended by omitting therefrom the words "thirtieth day of March 1954" and substituting therefor the words "first day of May 1954".
