

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as the *New Norfolk Sewerage Loan Act 1948*. Short title.

2 The Council for the Municipality of New Norfolk on behalf of that Corporation may raise a sum of money not exceeding in the whole the sum of One thousand four hundred pounds by the sale of debentures under the provisions of the *Local Government Act 1906** and the *Local Bodies Loans Act 1881†*. Council may borrow £1400.

3 The amount so borrowed shall be used to reimburse the Council for the loss incurred by the Council in the execution of certain works under the provisions of the *New Norfolk Sewerage Act 1941‡*. Use of moneys borrowed.

4 The moneys secured by the said debentures shall be made payable over a period of twenty-five years from the date of issue and such payments of principal and interest moneys shall be charged upon and paid out of the sewerage rate authorized to be levied by section five of the *New Norfolk Sewerage Act 1941‡*. Security and repayment.
