AN ACT to amend the *Launceston Corporation Act* 1894 and its Amendments. [16 November, 1938.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament, assembled, as follows:—

1 This Act may be cited as the *Launceston Corporation Act* 1938. Short title.

2 It shall be lawful for the Municipal Council of the City of Launceston to pay to the Launceston Public Library out of the revenues of the Corporation an annual sum not exceeding five hundred pounds.

3—(1) Section fifteen of the *Launceston Corporation Act Amendment Act* 1918, is hereby amended by inserting after the words “authorised witness” in line ten thereof the words “or a person entitled to vote at such election.”

(2) Form A in the schedule to the *Launceston Corporation Act Amendment Act* 1918, is hereby amended by inserting the words “a person entitled to vote at the election or” after the words “must be” in line twenty thereof, and the words “in Tasmania, or a postmaster or postmistress or person in charge of a post office, a Commonwealth Electoral Registrar, a Commissioner of the Supreme Court of Tasmania, or a Notary Public outside Tasmania,” at the end thereof.

4 Section twenty-seven of the *Launceston Corporation Act* 1894, is hereby amended by deleting the words “fourteenth” from the first line, and “seventh” from the second line of subsection (2) thereof, and substituting therefor the words “twenty-first” and “fourteenth” respectively.
