AN ACT to make provision for Meeting the 1940 Discount and Expenses in connection with the borrowing of certain moneys by the State. [15 November, 1940.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

1 This Act may be cited as the Loans (Flotation Expenses) Short title. Act 1940.

Power to borrow £115,773 5s. to meet discount and expenses.

2 The Treasurer may raise, borrow, and receive any sum or sums of money not exceeding in the aggregate the sum of one hundred and fifteen thousand seven hundred and seventy-three pounds five shillings and apply the same in payment of the discount payable and expenses incurred in connection with the raising of the loans authorised by the Acts set out in the schedule.
