**AN ACT to authorize the issue and application of certain further moneys from the Loan Fund for the service of the year ending on 30th June 1975.**

[21 November 1974]

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—(1) This Act may be cited as the *Loan Fund Appropriation Act (No. 2) 1974-1975*.

(2) This Act shall be deemed to have commenced on 1st July 1974.

**2—(1)** In addition to the sums of money authorized by any other Act to be issued out of the Loan Fund for the service of the year ending on 30th June 1975, the Treasurer may, subject to this Act, issue out of that Fund for the service of that year further sums of money not exceeding in the whole \$6 947 000.

(2) The sums authorized to be issued out of the Loan Fund by this Act are appropriated for, and shall be applied for, the works and purposes specified in the Schedule.

Borrowing  
powers.

**3—(1)** The Treasurer may arrange for the borrowing on behalf of the State, in accordance with the Financial Agreement, of the sum of \$4 717 000.

(2) The sum authorized to be borrowed by subsection (1) is in addition to the sums authorized to be borrowed by the *Loan Fund Appropriation Act 1974-1975*.
