# LOAN FUND APPROPRIATION (No. 3) 1971-1972.

No. 1 of 1972.

AN ACT to authorize the issue and application of certain further moneys from the Loan Fund for the service of the year ending on the thirtieth day of June 1972. [7 April 1972.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1—(1) This Act may be cited as the Loan Fund Appropriation Short title and commencement.
- (2) This Act shall be deemed to have commenced on the first day of July 1971.

**2**—(1) In addition to the sums of money authorized by any other Act to be issued out of the Loan Fund for the service of the year ending on the thirtieth day of June 1972, the Treasurer may, subject to this Act, issue out of that Fund for the service of that year further sums of money not exceeding in the whole \$2,700,000.

(2) The sums authorized to be issued out of the Loan Fund by this Act are appropriated for, and shall be applied for, the works and purposes specified in the schedule.

#### Borrowing powers.

- **3**—(1) The Treasurer may arrange for the borrowing on behalf of the State, in accordance with the Financial Agreement, of the sum of \$1,580,000.
- (2) The sum authorized to be borrowed by subsection (1) of this section is in addition to the sums authorized to be borrowed by the Loan Fund Appropriation Act 1971-1972 and the Loan Fund Appropriation Act (No. 2) 1971-1972.
