

1—(1) This Act may be cited as the *Guest Houses Registration Act 1962*. Short title and citation.

(2) The *Guest Houses Registration Act 1937*, as subsequently amended, is in this Act referred to as the Principal Act.

2 Section two of the Principal Act is amended by inserting in paragraph (a) of the definition of "guest house", after the word "providing", the words "lodging or both". Interpretation.

3 Section four of the Principal Act is amended by inserting in paragraph (a) of subsection (6) thereof, after the word "with" (first occurring), the words "lodging or, as the case may be, with". Registration of guest houses.

TASMANIAN ORCHESTRA (CONTINUATION).

AN ACT to amend the *Tasmanian Orchestra (Continuation) Act 1951*. [1 October 1962.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Tasmanian Orchestra (Continuation) Act 1962*. Short title and citation.

(2) The *Tasmanian Orchestra (Continuation) Act 1951*, as subsequently amended, is in this Act referred to as the Principal Act.

2 Section three of the Principal Act is amended by omitting therefrom the numerals "1963" and substituting therefor the numerals "1966". State contribution.

LAUNCESTON FLOOD PROTECTION.

No. 33 of 1962.

AN ACT to amend the *Launceston Flood Protection Act 1960*. [1 October 1962.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

and citation.

1—(1) This Act may be cited as the *Launceston Flood Protection Act 1962*.

(2) The *Launceston Flood Protection Act 1960* is in this Act referred to as the Principal Act.

Financial.

2 Section thirteen of the Principal Act is amended by omitting from subsections (1), (2), and (3) the numerals "850,000" (wherever occurring) and substituting therefor, in each case, the numerals "1,200,000".

FRUIT BOARD.

No. 34 of 1962.

AN ACT to amend the *Fruit Board Act 1934* and to validate certain payments made by the State Fruit Board by way of travelling allowances or living allowances. [1 October 1962.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title
and citation.

1—(1) This Act may be cited as the *Fruit Board Act 1962*.

(2) The *Fruit Board Act 1934*, as subsequently amended, is in this Act referred to as the Principal Act.

Expenses
of Board.

2 Section six of the Principal Act is amended by omitting subsection (1) and substituting therefor the following subsection:—

"(1) The Board may pay out of its funds to a member of the Board such fee as the Governor may determine for each day on which that member attends a meeting of the Board and, in respect of the attendance of that member at meetings of the Board or of his engaging on any business authorized by the Board, such travelling or other allowances as may be prescribed."

Application
of funds
of Board.

3 Section eighteen of the Principal Act is amended by omitting subsection (5) and substituting therefor the following subsections:—

"(5) Subject to subsection (6) of this section, the Board may, for any purposes connected with the exercise of its functions, expend out of its funds such sums as it thinks proper.
