

LOCAL GOVERNMENT (CONSEQUENTIAL AMENDMENTS) ACT 1982

No.	51	of	1982

AN ACT to amend the Local Government Act 1962, the Police Offences Act 1935, the Roads and Jetties Act 1935, the Justices Act 1959, and the Land Titles Act 1980 for the purpose of making amendments to those Acts that are consequential to the Local Government (Highways) Act 1982.

[Royal Assent 23 December 1982]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1—This Act may be cited as the Local Government (Conse- short title. quential Amendments) Act 1982.
- **2**—(1) This section and section 1 shall commence on the day commence on which this Act receives the royal assent.
- (2) Except as provided in subsection (1), the several provisions of this Act shall commence on the day fixed by proclamation under section 2 (2) of the Local Government (Highways) Act 1982.

3—In this Act, the Local Government Act 1962* is referred to as the Principal Act.

Amendment of section 362 of Principal Act (Enforcement of building estate owner's duty).

- **4**—(1) Section 362 of the Principal Act is amended by omitting subsections (1), (2), and (3) and substituting the following subsection:—
 - (1) The owner of a building estate shall not without leave of the corporation sell or offer for sale a lot in the estate unless, in respect of the highways opened or to be opened on the building estate, either—
 - (a) a certificate of completion has been issued under section 10 (5) of the Local Government (Highways) Act 1982; or
 - (b) security has been given under section 11 (6) of that Act or section 467 of this Act for the costs of carrying out the works necessary for such a certificate to be granted.
- (2) Section 362 (4) of the Principal Act is amended by omitting "subsection (2)" and substituting "subsection (1)".
- (3) Section 362 of the Principal Act is further amended by omitting subsection (5).

Amendment of section 467 of Principal Act (General requirements).

- **5**—Section 467 (3) of the Principal Act is amended by omitting paragraph (*bab*) and substituting the following paragraph:—
 - (bab) the works required for the discharge of the owner's obligations under section 10 of the Local Government (Highways) Act 1982 in respect of highways opened or to be opened on the building estate;

Amendment of section 694 of Principal Act (The municipal map).

- **6**—Section 694 (1) of the Principal Act is amended as follows:—
 - (a) by omitting paragraph (a) and substituting the following paragraph:—
 - (a) all local highways maintainable by it;
 - (b) by omitting from paragraph (d) "Division 11 of Part XV" and substituting "Part V of the Local Government (Highways) Act 1982";
 - (c) by omitting from paragraph (e) "section 378" and substituting "section 63 (2) of the Local Government (Highways) Act 1982".
