**AN ACT to repeal legislation that is no longer required**

**[Royal Assent 22 September 1995]**

**B**E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

#### **Short title**

**1**—This Act may be cited as the *Legislation Repeal Act 1995*.

**Commencement**

2—This Act commences on the day on which it receives the Royal Assent.

**Repeal of Acts**

3—The Acts specified in Schedule 1 are repealed.

**Rescission of regulations**

4—The regulations specified in Schedule 2 are rescinded.

**Expiry of Act**

5—This Act expires 90 days after it commences.

**Administration of Act**

6—Until provision is made in relation to this Act by order under section 4 of the *Administrative Arrangements Act 1990*—

- (a) the administration of this Act is assigned to the Minister Assisting the Treasurer; and
  - (b) the Department responsible to the Minister Assisting the Treasurer in relation to the administration of this Act is the Department of Treasury and Finance.
