

LAUNCESTON SWAMP LAND.

No. 31 of 1955.

AN ACT to repeal the *Launceston Swamp Land Sale Enabling Act 1917* and to appropriate the sum of one thousand one hundred and sixty pounds in full settlement of moneys owing to the Marine Board of Launceston under that Act. [21 October, 1955.]

WHEREAS under the provisions of the *Launceston Swamp Land Sale Enabling Act 1917* the Commissioner of Crown Lands was authorized to enter into and carry out an agreement with the Marine Board of Launceston (in this Act referred to as "the Board") providing for the payment to the Board of annual sums of money equivalent to interest at the rate, upon the conditions, and for the period set out in the third schedule to that Act, upon the Board surrendering to the Crown all its right, title, and interest in a lease dated the first day of July 1914, granted by the Governor to the Board for the term of ninety-nine years of (*inter alia*) certain land situate in the city of Launceston and more particularly specified in the first schedule to that Act: Preamble.

And whereas the Commissioner of Crown Lands duly entered into an agreement with the Board as provided for in that Act:

And whereas there remains owing to the Board under the Act and agreement above recited fifty-eight annual instalments of sixty-two pounds each:

And whereas the Board is willing to accept the sum of one thousand one hundred and sixty pounds in full settlement of the moneys still remaining due to the Board under that Act and the agreement:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Launceston Swamp Land Act 1955*. Short title and repeal.

(2) The *Launceston Swamp Land Sale Enabling Act 1917* is hereby repealed.

Commutation
of liability.

2 All the remaining liability of the State to the Board under the Act and agreement above recited shall cease, and in lieu thereof the Board shall be entitled to the payment of the sum of one thousand one hundred and sixty pounds before the thirtieth day of June 1956.

3—(1) The Treasurer may issue out of the Consolidated Revenue (which, to the necessary extent, is appropriated accordingly) the sum of one thousand one hundred and sixty pounds and apply that sum for the purposes of section two of this Act.

(2) The sum appropriated by subsection (1) of this section shall be applied in the financial year ending on the thirtieth day of June 1956.

NARACOOPA JETTY.

No. 32 of 1955.

AN ACT to enable the building of a jetty in the Port
of Naracoopa. [21 October, 1955.]

Preamble.

WHEREAS it is proposed that the Crown build a jetty in the Port of Naracoopa in the jurisdiction of the Marine Board of King Island (in this Act called "the Board") partly out of moneys provided by King Island Scheelite (1947) Limited a company registered under section two hundred and sixty-four of the *Companies Act* 1920 (in this Act called "the Company") and to let the jetty to the Board on condition among others that the Board give the Company certain advantages in the use of the jetty:

And whereas it is expedient to exclude the operation of certain enactments and rules of law standing in the way of that proposal:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title.

1 This Act may be cited as the *Naracoopa Jetty Act* 1955.
