

STATUTORY AUTHORITIES EXPENDITURE.

No. 40 of 1954.

AN ACT to amend the *Statutory Authorities Expenditure Act 1953.* [19 October, 1954.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title,
citation, and
commence-
ment.

1—(1) This Act may be cited as the *Statutory Authorities Expenditure Act 1954.*

(2) The *Statutory Authorities Expenditure Act 1953* is in this Act referred to as the Principal Act.

(3) This Act shall be deemed to have commenced on the twenty-ninth day of June 1954.

Expiry of
Act.

2 Section three of the Principal Act is amended by omitting the words “thirtieth day of June,” and substituting therefor the words “thirty-first day of December”.

LATROBE WATER.

No. 41 of 1954.

AN ACT to amend the *Latrobe Water Act 1943.* [19 October, 1954.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title
and citation.

1—(1) This Act may be cited as the *Latrobe Water Act 1954.*

(2) The *Latrobe Water Act 1943*, as subsequently amended, is in this Act referred to as the Principal Act.

2 Section twenty-four of the Principal Act is amended— Separate local rate.

- (a) by omitting from subsection (1) the words “two shillings and sixpence” and substituting therefor the words “six shillings”;
- (b) by omitting from subsection (2) the words “seven shillings and sixpence” and substituting therefor the words “fifteen shillings”, and by omitting from that subsection the words “one pound five shillings” and substituting therefor the words “two pounds ten shillings”; and
- (c) by omitting subsection (5).

EXTON WATER.

No. 42 of 1954.

AN ACT to amend the *Exton Water Act 1947*. [19 October, 1954.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Exton Water Act 1954*. Short title and citation.

(2) The *Exton Water Act 1947*, as subsequently amended, is in this Act referred to as the Principal Act.

2 Section twenty-three of the Principal Act is amended— Council may levy rates.

(a) by omitting subsection (1) and substituting therefor the following subsection:—

“(1) The Council shall make and levy a flat rate for properties within the water district of such amount as it may think fit, but not exceeding—

- (a) thirty pounds for every farm property containing an area of one hundred acres or more;
- (b) fifteen pounds for every farm property containing an area of less than one hundred acres;
- (c) twelve pounds for every house, building, or premises separately occupied for domestic purposes; and
- (d) one pound for every vacant allotment of land separately assessed in the assessment roll.”; and

(b) by omitting subsection (4).
