

AN ACT to amend the Marine Act 1921. [17 December, 1935.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

.1 This Act may be cited as the Marine Act (No. 2) 1935.

Transitory provisions.

2 The Principal Act is hereby amended—

- I. By expunging subsections (2) and (3) of section twenty-two thereof and substituting therefor the following new subsection (2):—
 - "(2) Subject to the provisions of this Act and to such transitory provisions as may be prescribed for securing rotational retirements, each warden shall hold office for three years.":
- II. By inserting "in each year" (after "December" in section twenty-three thereof):
- III. By substituting for repealed sections twenty-four and twenty-five the following new sections twenty-four and twenty-five:—
 - "24 Two of the wardens shall retire in each of the two years next after the enactment of this section, and the fifth warden shall retire in the third year after such enactment; and, in each succeeding period of three years thereafter, the retirement shall be two each in the first and second years, and one in the third year, of such period respectively."
 - "25 The Board shall pay to the Council of the City of Launceston such sum as shall be necessary to recoup the Council for the expense, or additional expense, as the case may be, of holding an election for the purposes of this Act, and in case of dispute the amount to be so paid shall be determined by the Auditor-General, whose decision shall be final."
- 3 The Marine Act 1935 is hereby amended as from its commencement by inserting in the first schedule thereto (after the figures "10" in the third column) the numerals, "23, 25, 26, 26c, 26i, 26k, and 85a", and by substituting "Second" "Third" and "Fourth" for "Third" "Fourth" and "Fifth" respectively (in the amendment of the schedules of the Principal Act in the second column of the second schedule thereto); and by inserting (in the first and second columns after section eighty-nine) "Section one hundred and twenty-four subparagraph" and substituting "Paragraph".
- 4—(1) On the ninth day of January, one thousand nine hundred and thirty-six, all the wardens of the Marine Board of Launceston then in office shall retire, and an election shall be held on that day by the Council of the City of Launceston for the election of five members of the Board.
- (2) Such election shall be held as aforesaid in accordance with the provisions of the Principal Act in the same manner and, except as herein provided, subject to the same conditions as if it were an election as provided by section twenty-three of the Principal Act.

- (3) Nominations for election to the Board at the election to be held as aforesaid shall be received up to four of the clock in the afternoon of the thirty-first day of December, one thousand nine hundred and thirty-five.
 - (4) The wardens elected at such election shall retire as follows—
 - I The warden elected by the greatest number of votes—in the year one thousand nine hundred and thirty-eight:
 - II. The two Wardens elected by the next highest number of votes—in the year one thousand nine hundred and thirty-seven: and
 - III. The two wardens elected by the least number of votes—in the year one thousand nine hundred and thirty-six—

on the days appointed for holding elections in each of those years respectively under section twenty-three of the Principal Act, and thereafter the wardens shall retire as provided by section twenty-four thereof.

- (5) The two wardens who represent, respectively, the Municipality of Beaconsfield and the Municipalities of George Town, Lilydale, and St. Leonards shall retire on the thirty-first day of December, one thousand nine hundred and thirty-five.
- 5 Sections twenty-four to twenty-six A of the Principal Act are hereby repealed.
