AN ACT to provide for the Application of 1935. certain Provisions of the Merchant Shipping

Act 1894 to Shipping and Seamen in this State. [16 January, 1936.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as the Merchant Seamen Act 1935.

Short title.

2 The Acts enumerated in the schedule are hereby repealed.

#### Merchant Seamen.

#### A.D. 1935.

Application of Part II. of 57 and 58 Vict. c. 60.

3—(1) The provisions of Part II. of the Merchant Shipping Act 1894 which do not otherwise so apply shall, as modified by this Act, apply to all British ships registered at, trading with, or being at any port in this State and to the owners, masters, and crews thereof.

(2) For the purposes of this section and in the application of the said provisions, the expressions "Board of Trade" or "Board" and "United Kingdom" used therein shall be construed to refer to the "Governor" and "this State" respectively.

(3) Where in the said provisions any reference is made to any officer or class of officers, the Governor by order in council may designate the officer or officers who in this State are to perform the duties and stand in the place of the officer or officers to whom reference is so made.

(4) The said provisions, so far as they relate to property of a deceased seaman which is unclaimed for six years, shall be construed as providing that such property or the proceeds thereof, shall be paid into the Consolidated Revenue, where not otherwise applied under those provisions.

### Appointment of officers.

4—(1) The Governor may appoint mercantile marine offices at such ports as he may think fit, and may appoint shipping masters, clerks, and other officers for the purposes of this Act.

(2) Such shipping masters shall have and perform the same duties in all respects as are performed by superintendents of mercantile marine offices appointed under the *Merchant Shipping Act* 1894.

#### Regulations

5-(1) The Governor may make regulations for the purposes of this Act.

(2) Such regulations may prescribe the fees which shall be payable in respect of any matters under this Act.
