## NORTH-WESTERN CO-OPERATIVE FREEZING. AND CANNING COMPANY'S LOAN.

## No. 30 of 1951.

AN ACT to amend the North-Western Co-operative Freezing and Canning Company's Loan Act 1913, the North-Western Co-operative Freezing and Canning Company's Loan Act 1935, and the North-Western Co-operative Freezing and Canning Company's Loan Act 1937. [18 May, 1951.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- "(1) The amount of all moneys advanced to the Company under this Act shall, until the repayment in full thereof, and the amount of all interest from time to time payable in respect of those moneys, shall, until the payment thereof, by the Company, be and remain a first charge upon all land and buildings of the Company, whether purchased, acquired, or erected by the Company before or after the commencement of this subsection."
- 3 Section nine of the North-Western Co-operative Freez-Amendment of ing and Canning Company's Loan Act 1935; is amended by Act of 1985. omitting subsection (1) thereof and substituting therefor the following subsection:—
- "(1) The amount of all moneys advanced to the Company under this Act shall, until the repayment in full thereof, and the amount of all interest from time to time payable in respect of those moneys, shall, until the payment thereof, by the Company, be and remain a first charge upon all land, and buildings of the Company, whether purchased, acquired, or erected by the Company before or after the commencement of this subsection."

4 Section nine of the North-Western Co-operative Freez- Amendment of ing and Canning Company's Loan Act 1937; is amended by Act of 1937. omitting from subsection (1) thereof all the words after the word "upon" to the end of that subsection and substituting therefor the words "all land and buildings of the Company, whether purchased, acquired, or erected by the Company before or after the commencement of this Act.".
