## AN ACT to amend the Public Account Act 1986

# [Royal Assent 16 December 1994]

**B**E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

#### Short title

1—This Act may be cited as the *Public Account Amendment* Act 1994.

#### Commencement

2—This Act commences on the day on which it receives the Royal Assent.

### Principal Act

3—In this Act, the *Public Account Act 1986\** is referred to as the Principal Act.

# Section 8 amended (Consolidated Fund: Expenditure and revenue)

- 4-Section 8 of the Principal Act is amended as follows:
  - (a) by omitting paragraph (c) from subsection (5) and substituting the following paragraph:—
    - (c) all money borrowed for the purposes of an Appropriation Act; and
  - (b) by inserting after paragraph (e) of subsection (5) the following paragraph:—
    - (ea) all money received from the provision of goods and services by a Government department or in the administration of a special appropriation unless the Treasurer determines otherwise; and
  - (c) by inserting in subsection (5A) "or (5) (ea)" after "(5) (e)".

## Section 11 amended (Treasurer's reserve)

- 5—Section 11 of the Principal Act is amended as follows:—
  - (a) by omitting "and" at the end of paragraph (c) of subsection (2);

- (b) by omitting paragraph (d) of subsection (2) and substituting the following paragraphs:—
  - (d) if Commonwealth money to which this section applies, additional to that estimated in a statement accompanying an Appropriation Act, is received from the Commonwealth in that financial year, the amount of that additional Commonwealth money; and
  - (e) if receipts of a recurrent nature, additional to the total estimated receipts of a recurrent nature specified in a statement accompanying an Appropriation Act, are generated within that financial year, the amount of those additional receipts less the amount of any additional Commonwealth money referred to in paragraph (d) of a recurrent nature—
- (c) by omitting from subsection (5) "or (c)" and substituting "(c) or (e)".
