**AN ACT to amend the Public Health Act 1962.**

[Royal Assent 21 November 1985]

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—This Act may be cited as the *Public Health Amendment Act* Short title. 1985.

**2**—This Act shall commence on the day fixed by proclamation under section 2 (2) of the *Meat Hygiene Act 1985*.

**3**—In this Act, the *Public Health Act 1962\** is referred to as the Principal Act.

**4**—The following section is inserted in the Principal Act after section 62:—

Limitation on  
exercise of  
powers of  
inspectors.

62A—An inspector shall not exercise any of his powers under this Part in or on licensed meat premises within the meaning of the *Meat Hygiene Act 1985*.

**5**—Part VIII of the Principal Act is amended by omitting Divisions V and VA.

**6**—Section 116 of the Principal Act is amended as follows:—

- (a) by omitting “An ” from subsection (1) and substituting “ Subject to section 62A, an ”;
- (b) by omitting “An ” from subsection (2) and substituting “ Subject to section 62A, an ”;
- (c) by omitting “An ” from subsection (3) and substituting “ Subject to section 62A, an ”;
- (d) by omitting “An ” from subsection (4) and substituting “ Subject to section 62A, an ”.

**7**—Section 120 of the Principal Act is amended by inserting the following subsection after subsection (10):—

(11) For the purposes of this section, “ premises ” does not include licensed meat premises within the meaning of the *Meat Hygiene Act 1985*.

**9**—Section 120B (1) of the Principal Act is amended by inserting “, not being licensed meat premises within the meaning of the *Meat Hygiene Act 1985*,” after “ premises ”.
