AN ACT relating to the allowance under the *Payment of Members Act 1927* to *Arthur James Tyler*, in respect of the Legislative Council Division of Hobart. [27 April, 1944.]

WHEREAS *Arthur James Tyler* was, on the fifteenth day of September, 1943, declared to have been elected to the Legislative Council for the Division of Hobart at an election for the said Division held on the fourteenth day of September, 1943: Preamble.

And whereas on the twenty-second day of December, 1943, the Supreme Court, in accordance with the *Electoral Act 1907*,\* declared the election of the said *Arthur James Tyler* to be absolutely void:

*Payment of Members (Allowance to Arthur James Tyler).*

A.D. 1944. — And whereas on the twenty-second day of January, 1944, at the new election held in accordance with section one hundred and eighty of the said Act, the said *Arthur James Tyler* was elected for the said Division:

And whereas it is desirable to declare that the said *Arthur James Tyler* was, during the period between the fourteenth day of September, 1943, and the twenty-second day of January, 1944, entitled to receive and retain the allowance prescribed by the *Payment of Members Act 1927*<sup>†</sup> in respect of the said Division:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title.

**1** This Act may be cited as the *Payment of Members (Allowance to Arthur James Tyler) Act 1944*.

Declaration that allowance may be retained.

**2** It is hereby declared that *Arthur James Tyler* was, during the period between the fourteenth day of September, 1943, and the twenty-second day of January, 1944, entitled to receive and retain the allowance prescribed by the *Payment of Members Act 1927*<sup>†</sup> in respect of the Legislative Council Division of Hobart.
