AN ACT to amend the Primary Producers Relief Act 1946. [2 May, 1947.]

B^E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:---

1—(1) This Act may be cited as the Primary Producers Short title and Relief Act 1947.

(2) The Primary Producers Relief Act 1946*, as subsequently amended, is in this Act referred to as the Principal Act.

Grants to primary producers. **2** Section two of the Principal Act is amended by inserting after subsection (1) the following subsection:—

"(1A) If and in so far as the sums provided under this Act are not required for grants for the losses referred to in subsection (1), the Board may make a grant of money to any primary producer who has suffered loss as the result of abnormal climatic conditions in the years 1946 and 1947 out of the balance of the said sums provided under this Act remaining after payment of all grants for the losses mentioned in the Principal Act.".

3—(1) The Board shall reopen applications for relief under section two subsection (1) of the Principal Act and shall by public advertisement give notice that applications shall be received until the 31st day of May, 1947.

(2) The Board shall take such applications into consideration and notify its decision thereon and complete the distribution of payments upon such applications on or before the 30th day of September, 1947.

4 Section five of the Principal Act is amended by adding at the end of subsection (2) the words "and the thirtieth day of June, 1948.".
