AN ACT to amend the *Police Regulation Act* 1898. A.D. 1945.
[30 May, 1945.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Police Regulation Act* 1945. Short title and citation.

(2) The *Police Regulation Act* 1898*, as subsequently amended, is in this Act referred to as the Principal Act.

3 Section forty-two of the Principal Act is amended by omitting subsection (9).

4 Section forty-four of the Principal Act is repealed and the following sections substituted therefor:—

“44—(1) The Treasurer shall pay to the Fund, out of the Consolidated Revenue, by way of contribution on the part of the State to the benefits and allowances payable to police officers under this Act, an amount of £3000 in the financial year commencing on the first day of July, 1945, and in each subsequent financial year such amount as Parliament provides for that purpose.

(2) The amount payable to the Fund under this section shall be credited to the superannuation branch of the Fund.

“44A—(1) The amount standing to the credit of the reward branch of the Fund at the commencement of this section, and all accumulations thereof, together with such amounts as may be provided in accordance with subsection (2), shall be used for the purpose of providing for the payment of rewards, in accordance with the regulations, to police officers for extraordinary diligence and exertion, or as compensation for wounds or severe injuries received, in the performance of their duties.

(2) There shall be paid to the credit of the reward branch of the Fund, by way of contribution on behalf of the State to the payment of rewards as provided by subsection (1), such amounts as Parliament provides for that purpose.”.

5 The regulations under the Principal Act made on the first day of March, 1945, and gazetted on the fourteenth day of March, 1945, shall be deemed to have taken effect on and from the first day of January, 1945.
