SCHEDULE 1
STATUTORY RULES

AN ACT to validate certain regulations and certain rules of the Supreme Court that have ceased to have effect owing to the failure to have them laid before each House of Parliament within the period specified in section 47 (3) (c) of the Acts Interpretation Act 1931 and to provide for related matters.

[Royal Assent 23 December 1982]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the Regulations (Validation) Act short title. 1982.

Commencement. **2**—This Act shall commence on the day on which it receives the royal assent.

Validation of certain regulations and certain rules of the Supreme Court

- **3**—(1) Each statutory rule that is specified in Schedule 1, being regulations or rules of the Supreme Court that were not laid before each House of Parliament within the period specified in section 47 (3) (c) of the Acts Interpretation Act 1931—
  - (a) shall be deemed to have been laid before each House of Parliament within that period; and
  - (b) shall be valid and effectual, and shall be deemed during the prescribed period to have been valid and effectual.
- (2) In subsection (1) (b), "prescribed period", in relation to a statutory rule that is specified in Schedule 1, means the period commencing on the date on which that statutory rule was purported to have taken effect and ending immediately before the commencement of this Act.
- (3) Any payment purportedly made or demanded, or any other act or thing purportedly done, before the commencement of this Act, under or in pursuance of a statutory rule that is specified in Schedule 1 shall be deemed to have been validly and effectually made, demanded, or done under or in pursuance of that statutory rule.
- (4) Nothing in this section affects or prejudices the operation of section 47 (4) of the *Acts Interpretation Act* 1931 in relation to a statutory rule that is specified in Schedule 1.
